

The Northfield Portfolio Optimizer enables managers to construct portfolios that deliver more return for each level of risk while incorporating manager preferences and market outlook. Additionally, Northfield's optimizer and risk models can explicitly account for non-normal return distributions that arise in many portfolios, including credit risk, counterparty risk, options and emerging markets.

Clients can also access Northfield's Risk Systems That Read (RSTR). These models blend news flows, implied volatility, cross-sectional dispersion, and historical relationships to provide traders and quants with novel and differentiated near-horizon risk forecasts.
